SPONSOR

SWEEPSTAKES AND PROMOTION DESCRIPTION

The UnitedHealthcare 2024 Qorvo Mammogram Sweepstakes (the "Sweepstakes") has a promotion period that is announced on or about May 28, 2024, at 12:01 a.m. Eastern Time ("ET") and ends on December 31, 2024, at 11:59 p.m. ET (the "Promotion Period"). Entry in the Sweepstakes does not constitute entry into any other promotion, contest, or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects.

ELIGIBILITY

The Sweepstakes is open only Qorvo employees and spouses enrolled in a 2024 UnitedHealthcare medical plan. Void where prohibited or restricted by law.

SWEEPSTAKES ENTRY

To enter, simply complete a mammogram screening between January 1, 2024, and November 30, 2024. The Sponsor shall not be responsible for incorrect or inaccurate entry information or by any technical or human error which may occur in the processing of the entries in the Sweepstakes.

WINNER SELECTION

A random drawing will be conducted from among all eligible entries received by the end of the Promotion Period. The potential prize winners will be notified mailed letter. Sponsor has no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within ten (10) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact potential winner of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it

remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate prize winner may be selected. **The odds of winning depend on the number of eligible entries received.**

PRIZES

Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these official rules or disruptive manner. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

RELEASE AND LIMITATION OF LIABILITY

CONSTRUCTION

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. GOVERNING LAW/JURISDICTION
